Re: 2026 Pre-Budget Consultation Submission

Dear Minister Legacy,

Human trafficking is not well understood in Canada. Contrary to what is depicted in the media, human trafficking is often more subtle and usually perpetrated by someone the victim/survivor already knows. While anyone can be a target of trafficking, individuals experiencing poverty, housing instability, homelessness, precarious immigration status and other social challenges are at a higher risk. We urge policymakers to develop a holistic anti-human trafficking strategy that prevents individuals from being exploited and addresses gaps that make it difficult for victims/survivors to leave their trafficking situation.

Many Canadians are unaware that human trafficking is occurring in their own communities; however, data from Statistics Canada (Sutton-Preddie, 2025) and the Canadian Human Trafficking Hotline (CCTEHT, 2025, p. 16) show that this issue impacts every region across Canada, including small and rural municipalities in New Brunswick.

We know that your government has taken some steps to address human trafficking, including identifying sex trafficking within your broader sexual violence framework, and funding human trafficking training and awareness at the community level.

While these are important steps in the right direction, more work is needed if we are to end human trafficking in our time. The 2026 provincial budget provides an important opportunity to build on current initiatives and to address ongoing gaps.

Human trafficking spans many policy areas and cannot be addressed by a single ministry or government. Victims/survivors often depend on a range of public services, such as housing, healthcare, education, mental health and addiction support, legal aid, and employment services. The most requested referrals on the hotline between 2019 and 2024 were housing and shelter for victims/survivors of sex trafficking and legal services for labour trafficking victims/survivors (CCTEHT, 2025, p. 16).

A comprehensive and whole-of-government strategy is, therefore, desperately needed. Such an approach would prevent trafficking by addressing root causes, applying a trauma-informed lens, and incorporating insights from individuals with lived experience. At the heart of this approach is the creation of provincial coordinating bodies – a New Brunswick Office to Combat Human Trafficking, and a Survivors’ Advisory Committee – to oversee and lead strategy implementation.

Fortunately, you do not need to create this approach from scratch: Ontario and Alberta have developed their own dedicated strategies that can be replicated and adapted by New Brunswick. Similarly, the province of Nova Scotia, while lacking a public-facing strategy, has also made significant strides in coordinating efforts to end human trafficking.

Through our work, one thing has become very clear: provinces that have dedicated strategies are better positioned to lead prevention efforts and support victims/survivors. Therefore, we believe that prioritizing the development of an anti-human trafficking strategy in the 2026 budget is critical.

Thank you for considering this submission. We would welcome the opportunity to discuss how we can support you in furthering anti-trafficking work in the province.
